5.3 HSBC have now introduced a £60/year charge. Free banking options to be investigated. – Co-Op Bank suggested as a good alternative, though fear is that they may all move to a monthly charge sooner Committee agreed with Mike's proposal to hold on changing pending the outcome of the review into

possible transfer to affiliate status.

5.4 Funds from Cycling Events:

Following agreement on way forward at the last meeting, Sel proposed the following wording for the Constitution.

"Organisers are to provide the name of any charity(s) that the organiser would like to support to the Committee prior to the event. The Committee will check that the proposed charity(s) meets CUK acceptance criteria and reach an agreement with the Organiser on where any surplus is to be paid. After the event the organiser must present a detailed account of income and expenditure for review / audit by the Club Treasurer and pay any surplus to the MG accounts. The Treasurer will then make any agreed charitable donations to the selected Charities.

In exceptional circumstances where there is an identified need for funds, the Committee may require any surplus to be retained by the MG."
